# CDAM Criminal Defense Trial Practice College Returns!

We are emerging from an unprecedented period in the practice of law ... where we were facing pixels instead of people. And if the gathering has been in a shared, in-person space, the faces have been masked. This year's four-and-a-half-day program will address what it now means to "make an appearance" ... be it voir dire, laying foundations, making objections, opening statements, examinations, or closing arguments.

Whether remote or live, courtroom communication is interactive, so this intensive program is primarily "on your feet" training to provide attendees a real feel for utilizing the techniques, which cannot happen taking notes during lectures. Programming will run from 9 a.m. to 9 p.m. to give students the full benefit of training with some of the best and most experienced criminal defense attorneys in Michigan, as well as internationally recognized trial consultant and CLE trainer, Joshua Karton.

To ensure each attendee receives multiple opportunities to practice and receive direct feedback and analysis under the guidance of workshop faculty and peer review, registration is limited to 40 defenders. All are encouraged to bring their own cases to use in the skills exercises in the small break-out groups. This small group work guarantees everyone the opportunity for "hands on" practice with individualized attention and a high faculty to student ratio to maximize personal mentoring.

This training is geared to change methods and style of practice and to also enhance each participant's outlook on clients and career.

Trial College is planned by the CDAM Education Committee and is funded by registration fees and the occasional grant. CDAM is pleased to be the beneficiary of a 2022 grant from the State Bar of Michigan Litigation Section. The grant will help defray costs associated with running the program, award student scholarships, and host the first ever cocktail reception and dinner on the program's fourth evening. An anonymous benefactor has also donated five \$1,000 scholarships.



CDAM was formed in 1976 by criminal defense attorneys throughout Michigan to provide resources for criminal defense practitioners in Michigan. A primary goal is to enhance the quality of representation for indigent defendants.

# The Trial College

## Expectations

The college is designed as a residential program: students are expected to lodge at the hotel. Once enrolled, attendance is required at all sessions. The benefits of the residential approach have proven manifold: maximum exposure to the guided preparation and tutorial practice sessions held in the after-dinner-break session; building relationships which strengthen our practices; forming a network of support that connects participants long after the closing ceremony. Students are expected to lodge at the hotel, so there is no reduced/separate rate for exceptions. Once fees are paid, CDAM will make all necessary arrangements for hotel accommodations.

## Tuition

Tuition is \$1440.00 with single occupancy accommodations at Bay City Doubletree Hilton; double occupancy \$1220.00. Fee includes course materials, hotel, breakfast, lunch, snacks, and a closing night reception and dinner hosted by the State Bar of Michigan Litigation Section. **JOSHUA KARTON** specializes in the application of the communication techniques of theatre/film/television to the art of trial advocacy.
